Gentlemen:—

As you are soon to publish certain tombstone inscriptions in Tompkins County, N. Y., perhaps you may be willing to publish the following:

About sixty years ago marble tombstones were placed in a little cemetery about four miles from Ithaca located back of what was then called the West Hill or Haight (Hayt) school-house. These stones bore the following inscriptions:

Lewis Hall, died May 7, 1859, aged 76 years, 1 month and 5 days. Be ye also ready, for in such an hour as ye think not, death cometh.

Mary C. Hall, wife of Lewis Hall, died Dec. 25, 1854, aged 65 years, 2 months and 15 days. Although she be dead, she yet speaketh.

In 1913, after these stones became much weatherworn and broken, they were replaced with other marble stones, which unfortunately did not copy the original inscriptions, but read:

Lewis Hall, 1783-1859.
 Mary C. Hall, his wife, 1789-1854.

P. 21: Henry Disbrow, Senr., of Mamaroneck, to son Henry Disbrow, one half of all lands in Mamaroneck; reserving for life the field within the fence. Aug. 7, 1688.

P. 24: Thomas Whitlock and Mary his wife, living at Middleton, East Jersey, to Samuel Vail, land in Westchester. June 8, 1686. Acknowledged before John Pell, Justice for Westchester Co., by the persons of Thomas and Mary Whitlock, June 15, 1687; "not conveniently to acknowledge before this day; the persons living out of the Government."

P. 27: John Hadden, Senr. and Elizabeth his wife, of Westchester, to son John Hadden, Junr., land in Westchester; May 6, 1689. Signed "Haden."

P. 29: John Hadden, Senr. and wife Elizabeth, living near the saw-mill in Westchester, to son Edward Hadden, land in Westchester; bounded by land that did formerly belong unto John Laurence, Dutchman. May 6, 1689.

P. 31: John Hadden, Junr. and Edward Haden, both of Westchester, are held and firmly bound unto the Executors of the will of our father, John Hadden, Senr. of the same place, for the sum of one hundred pounds to be paid to sd. Executors for the use of our brother, Thomas Hadden. May 6, 1689.

P. 33: Mary Ponton, wife of Capt. Richard Ponton of Westchester, ae. 72 yrs. or thereabouts, being deposed, saith: That her son, John Lawrencson, was born at Newtown, L. I., in June of the year 1652. Sworn Apr. 28, 1689.

P. 36: Samuel Betts and John Betts, now living at ye Yonkers, bequeath unto John Barrett, our sister's son, one acre of salt meadow, s. w. of Stony Brook. Nov. 13, 1688.

GUERNSEY FAMILY LOT* (near Lansing, Tompkins Co., N. Y.).

Garnsey, Philo, d. Dec. 31, 1814, aged 50 years.

—? Irene, wife of —? (This stone was in such a bad condition that it was impossible to decipher any more of the inscription. I am informed, however, by letter from Wm. B. Murray, that Irene, wife of Philo Guernsey, was buried in this lot. This stone is next to the stone of Philo Guernsey, so it is probably that of Irene Guernsey, his wife. Philo Guernsey married Irene Murray; she was born Feb. 3, 1765. Mr. Murray was anxious to determine the date of her death, but it was impossible to decipher the stone beyond what is recorded above.)

Curtis, Josiah, d. April 3, 1831, aged 45 years, 6 mos.

Curtis, David, son of J. and R. Curtis, d. Sept. 2, 1827, aged 7 mos., 12 days.
Pulmor (?) or Fulnor (?), George, In memory of, d. Sept. 7, 1818, aged 18 years.

Bowker, Catherine, In memory of, daughter of Clinton and Mary Bowker, who died June 21, 1840, aged 4 years, 1 mo., 27 days.

Reynolds, M—? daughter of Elder E. J. and C. Reynolds, who died Aug. 19, 1838.

Gibbs, Sarah, wife of Barnabas Gibbs, In memory of, who died Aug. 14, 1837, aged 23 yrs., 22 days.

Jacobs, Polly M., wife of John Jacobs, born May 1, 1792; died April 4, 1832.

* This lot when visited was in an extremely neglected condition. A good many of the graves had stones to mark them, but very few of these stones were inscribed. The lot has not been used for many years. There must have been some 15 to 20 more graves than here recorded in the lot, but there was no way of identifying them. Mr. Wm. B. Murray spoke of others who were said to have been buried in this lot, but no sign could be found to identify their graves; they were possibly interred in the graves with the un-inscribed marking stones.
