She informed the Board of the work being done to implement the outreach and access priorities within our current budget. Business Manager Benjamin and Director Birdsall have begun work on the 2020 budget. The County's 2020 budget constraints will be shared at a public forum on May 8 at 9 am in the Borg Warner Community room, and Birdsall encouraged anyone interested to attend. Fabina Colon, Director of the Multicultural Resource Center will be invited to attend a Board meeting to discuss the possibility of the Library engaging with them for an equity assessment.

Report from the Foundation as shared by Annette:

Birdsall gave an update on the Readathon. Fundraising is at 50% of target which is typical for this time. The schedule was distributed, and sponsorships were applauded. Publicity in the Ithaca Voice Article and WHCU interview was noted along with 8am start and 11:30 finish times.

LIAISON REPORTS

Friends – D. Trotter reported 3,000 items selected by libraries on Library Day. Pre-sale began with a total of 272,000 items. Trotter requested trustees to volunteer at the sale.

County – A. Champion reported on the budget, tax cap and NYS ban on single use plastic bags. Champion encouraged the library to discontinue single use plastics.
