ASSISTANT DIRECTORS REPORT

Assistant Director Vadakin gave a reminder about December Meetings being earlier than usual due to the holiday. Dates are December 7th for Finance and Personnel and December 14th for the Board Meeting.

She gave an update on the new laptops for the Digital Lab, Evan was able to find 16 laptops that met our expectations last week. Computers and technology is hard to find right now due to pandemic affected supply chain issues. The new laptops have arrived and this will be really important for the digital lab, as we start programming in there again. Tom Fredette has found volunteers that will be offering tech help in there.

Meghan Molloy has taken over as Department Head of Adult Services. I have been working with Meghan closely.

Vadakin mentioned that Holiday Party planning is under way for the staff. We will have grab and go appetizers, desserts and this should work for all the staff. Grab and go made sense due to Covid and the varying comfort levels of the staff.

Vadakin mentioned that the Common Council voted against the 15,000 for funding Sundays, and due to this the Friends of the Library offered to support Sundays with a one-time Covid relief grant.

DISCUSSION OF CITY COUNCIL

TCPL requested funding for Sundays from Ithaca City, the Common Council voted against funding Sunday. A brief discussion ensued regarding barriers to access and Sunday users.

LIAISON REPORTS

County - A. Champion announced the legislators will vote on the budget tonight. Champion informed everyone that they are working on the County Administrator search process, interview was a failure. They will start another search early in the new year. Champion said there are five new legislators so far, they are waiting for Dryden, Mike Lane is up by 2 votes.

Foundation – K. Barnes remarked today is officially her second day. Barnes thanked everyone who attended the "Ask A Librarian" event. The foundation is in the process of reaching out to business and property managers and invited them for a tour of the library. Barnes said the foundation is focused on the Annual Appeal, she thanked the trustees who are assisting in the process.

Friends – D. Trotter said the sale is over, the building is empty. They will be accepting donations until April 16 and the sale is May 7^{th} . The Friends are in the process of taking donations and getting them on the shelves.
